Teachers will tell candidates which pieces of work will be used as evidence to inform their overall grade for each subject candidates have been entered for. Candidates will have the opportunity to raise any concerns about the evidence being used, for example, if the evidence was affected by personal circumstances, such as illness. Teachers will make the final judgement about what evidence is to be included - this is not a negotiation. Teachers will not be able to tell candidates the grades they will be submitting to the awarding bodies (exam boards). Candidates should not ask teachers what grade they have been awarded.
$\square$ When candidates will receive their grades results from the relevant awarding body (exam board).
After results have been received, there will be an appeals system as a safety net to fix any genuine errors that were not identified earlier in the determination of grades process, for example a number that has been incorrectly inputted due to a processing error.
